

## **B. CONSTRUCTION NOTES:**

- FINISHED GRADING SHALL BE DONE IN ACCORDANCE WITH THE PLOT PLAN. ALL DISTURBED AREAS SHALL BE COVERED WITH A MINIMUM OF 4" OF LOAM AND SEEDED WITH A NATIVE GRASS MIXTURE.
- PARKING AREA SHALL BE 3" GRAVEL IN ACCORDANCE WITH SSHB M.1.03.0 TYPE B OVER, 6" COMPACTED GRAVEL IN ACCORDANCE WITH SSHB M.1.03.0 TYPE B
- CONTRACTOR TO COORDINATE WITH APPROPRIATE UTILITY COMPANIES FOR ANY TEMPORARY DISCONNECTIONS AND SERVICES CONNECTIONS.
- 4. ALL CONSTRUCTION DEBRIS SHALL BE REMOVED FROM THE SITE AND DISPOSED OF IN ACCORDANCE WITH FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS.
