Kiosk and granite benches

Peter, Ray, Joan, and Paul Sebring installed the kiosk at Depot Street. An engraved plaque on the front of the kiosk acknowledges the donation from Townsend Community Couples Club.

Bill posted a map, trail information, and sponsor acknowledgement. He sent a photo to Amanda Lewis.

Five granite benches have been installed. Townsend Memorial did a great job at a very fair price.

Harbor Church projects

The Townsend Conservation Commission wants a detailed plan for the parking lot before they will consider amending our Orders of Conditions. Stan Dillis is working on the plan.

Townsend Harbor sidewalk and bike lanes

This joint project with Veronica Kell and the Town Administrator will use remaining funds from a Shared Streets grant.

Bill, Tim, and Cheryl Rideout measured street widths and provided the data to Kittleson & Associates. Their engineers determined that South Street is not wide enough for bike lanes on both sides, so the short term solution will be a lane on one side only. The longer term solution would be to widen the roads.

Bill, Tim, and Rick will meet with Townsend's Police Chief to ask him to reopen Old Meetinghouse Road for public safety. This would give us access to build a pedestrian bridge over the Squannacook River at no cost to the town

Opening celebration for phase 2

Saturday, September 24th at noon.

Veronica Kell can't attend, but will ask another Selectman. John Cronin will present a check for \$50K. Bill will present t-shirts to people who have helped during construction.

Bill sent an email and Facebook announcement asking people to park at Cherry Hill Tooand walk over or ride a shuttle. Pete and Rick will direct traffic. Bill will find out if the Council on Aging will loan their bus. Townsend CATV will record.

Bill will invite Community Foundation of North Central MA and Bruce J. Anderson Foundation.

Phase 3 and 4 construction

Bill sent a signed copy of the contract for phase 3 to Gary Shepherd. The agreed-upon amount is \$125,000 over four payments.

The phase 3 section has no wetlands, but Peter and Pete will do inspections based on best construction practices. We all need to record our volunteer time for the MassTrails grant.

We hope for another \$100K from MassTrails for phase 4. Bruce will look into applying for another CPA grant toward the 0.3 miles of phase 4 in Groton. Peter will submit another request for funding to Lori Trahan's office.

Other projects, events, and maintenance

Gary has been mowing and Bill weed-whacked. Chipmunks continue to dig holes in the stone dust.

Grants & other fundraising

Bill submitted an interim report to Community Foundation of North Central MA for our \$4,300 grant.

Brick sale is active in Groton until the end of September.

Financial report

At the end of phase 3, we will have \$84K remaining. If we win \$100K from MassTrails for phase 4, we will still need about \$40K to finish the trail.

Review minutes

A motion to accept the minutes of our August 17, 2022 meeting was seconded and passed unanimously.
